### On Energy Management Policy

#### 1) Principle

Focus on the development of alternative or renewable energy in various forms, promote the reuse of recycled resources, and increase the proportion of renewable or clean energy while reducing the use of fossil fuels in business operations to decrease pollution, minimize energy losses, and enhance energy efficiency.
5. Integrate environmentally friendly energy technologies and innovations into operational processes, ensuring optimal energy use.
6. Support and promote energy management and conservation in various aspects appropriately, including encouraging employees to participate in providing suggestions that contribute to the development and conservation of S&P’s energy resources.
